Campaign Material Do's and Don'ts

**Campaign Period begins April 6, 2021 at 09:01
& ends April 20, 2021 at 23:59**

- Candidates are reminded not to campaign and/or distribute material while conducting official union business.
- There is to be NO distribution of campaign material the day of the election.
- Campaign materials are not to be removed, defaced or destroyed by other Members. In the interest of a fair election and respectful trade union principles, this practice is prohibited.
- Candidates are responsible for making sure their campaign material is removed from the Properties by 18:00, April 20, 2021.
- No candidate or any other person soliciting support for a candidate may remain at or near the area of the polling on an election day.
- Candidates may appoint a person (Scrutineer) to be present at the vote count, at no expense to the Union.

ALL CANDIDATES ARE EXPECTED TO RUN A POSITIVE CAMPAIGN

Those interfering with any Election or Election Candidate's materials could be charged under Local 111 By-Laws and/or the Unifor Constitution.

****Unifor Elections Rule****

All members are automatically nominated for any vacant position(s). However, to stand for election, you must fill out an Acceptance of Nomination Form.

**Any nomination form submitted without a candidate's signature
WILL NOT be considered
and will be discarded!**

ACCEPTANCE OF NOMINATION FORM

- There shall be no distribution of election material on the days of the elections.
- All existing election materials must be removed by 1800 the day before the elections.
- No candidate for office or any other person soliciting support for any candidate may remain in or near the area of the polling booth on an election day.
- Candidates may appoint a person to be present at the vote count, at no expense to the Union
- All candidates are expected to run a positive campaign.
